NOTICE TO ALL TAX PAYERS IN THE MUNICIPALITY OF RED LAKE

If you own property in the Municipality of Red Lake, please note that the 2006 Final bill(s) were mailed on August 10th, 2006. The final due date for all taxes in all classes is October 31st, 2006.

If you did not receive your tax bill, please contact the Municipal Office at 735-2096 ext. 230. Failure to receive a bill does not absolve a taxpayer from responsibility for payment of taxes or penalty/interest charges.

Payments must be received before the due date. A penalty charge of 1.25% is added for non-payment the day after the due date, and the first day of each month thereafter until paid.

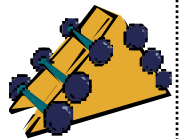
NEW EQUIPMENT AT THE RED LAKE COMMUNITY CENTRE
