## TO ALL TAXPAYERS IN THE MUNICIPALITY OF RED LAKE

If you own residential property in the Municipality of Red Lake, you should have received your 2003 final bill(s) in the mail by now. The due dates for property taxes are:

**The first installment is due August 29<sup>th</sup>, 2003**  
**The second installment is due October 31<sup>st</sup>, 2003**

The tax due dates for all classes of property are the same, however if you own property which is in the commercial, industrial or multi-residential property class or a combination of these classes, you will be receiving your bill at a later date.

If you have not received your residential tax bill, please contact the Municipal Office at 735-2096. Failure to receive a bill does not absolve a taxpayer from responsibility for payment of taxes or penalty/interest charges.

A penalty charge of 1.25% is added for non-payment the day after the due date and the first day of each month thereafter until paid.

Tax bills may be paid on or before the due date by mail or at any bank, in person or by way of telebanking or online banking. They may also be paid at the Municipal Office by way of cash, credit card, interac, cheque or postdated cheque.

**BY-LAW NO. 29- 98 DOGS AT LARGE**

To keep the dogs that are running at large under control, day, night and weekend patrols are being completed. To be in compliance with By-Law No. 29-98 dogs are required to be licensed after the age of six months. Dogs are not allowed to run at large, are not permitted to defecate on private or public property without immediate removal, and are not allowed to be in any areas designated as a municipally controlled public beach or playground where posted.
