NOTICE

MOTORIZED SNOW VEHICLES

The Municipality of Red Lake has been receiving complaints regarding motorized snow vehicles traveling on private property.

By-Law No. 5-01, as amended, states that no person shall operate a motorized snow vehicle on private property within the Municipality except where authorized to do so by the owner or occupier of the private property concerned.

DISABLED PARKING SPACES

As per By-Law No. 1046-08 no person or organization shall park a vehicle in a space designated for use by disabled persons, unless a currently valid permit has been issued to the person driving the vehicle, organization or to a person being picked up or transported in the vehicle, and such permit is displayed on or in the vehicle in accordance with the requirements of the Highway Traffic Act, and the regulation made under By-Law No. 1046-08.

Handicapped parking spaces are being monitored, and a \$300.00 ticket will be issued to any person who parks illegally in the handicapped spaces.
