NOTICE OF PASSING OF BY-LAW NO. 516-04 (DISSOLUTION OF THE WARD SYSTEM)

RE: BY-LAW NUMBER 516-04 REGARDING DISSOLUTION OF THE WARD SYSTEM
FOR THE CORPORATION OF THE MUNICIPALITY OF RED LAKE

Pursuant to *Section 222 (3) of the Municipal Act S.O., 2001, c.25, as amended*, notice is hereby given that the Council of the Corporation of the Municipality of Red Lake passed By-Law No. 516-04 at the Regular Meeting of Council held Tuesday, November 16th, 2004, regarding Dissolution of the Ward System.

The Minister or any other person or agency may appeal to the Ontario Municipal Board by filing a notice of appeal with the Municipality of Red Lake setting out the objections to the By-Law and the reasons in support of the objections. The appeal must be received in the Office of the Clerk by December 31st, 2004.
