

**THE CORPORATION OF THE MUNICIPALITY OF RED LAKE**

BY-LAW NO. 146-02

**BEING A BY-LAW TO AMEND BY-LAW 23-01  
A BY-LAW REGULATING THE STANDARDS FOR  
THE MAINTENANCE AND OCCUPANCY OF PROPERTY  
WITHIN THE MUNICIPALITY OF RED LAKE**

WHEREAS the Council of The Corporation of the Municipality of Red Lake approved By-Law No. 23-01 on April 3<sup>rd</sup>, 2001; and

WHEREAS it is deemed necessary to amend By-Law No. 23-01;

NOW THEREFORE the Council of The Corporation of the Municipality of Red Lake hereby ENACTS AS FOLLOWS:

1. THAT Section 2.2(2) be deleted and replaced with the following:

Inoperative Motor Vehicles, wrecked, dismantled, discarded or abandoned machinery, vehicles, trailers or boats unless it is necessary for the operation of a business enterprise lawfully situated on the property.

2. THAT the following definition of 'Inoperative Motor Vehicles' shall be added as Section 1.20 in Part I:

'Inoperative Motor Vehicles' includes a motor vehicle which may not be lawfully operated upon a highway pursuant to the Highway Traffic Act (Ontario) and amendments thereto because of any of the following reasons:

- (i) There is not in existence a currently validated permit for the vehicle;
- (ii) There are not displayed on the vehicle, in the prescribed manner, number plates issued in accordance with the Highway Traffic Act (Ontario) showing the number of the permit issued for the vehicle;
- (iii) There is not affixed to a number plate displayed on the vehicle evidence of the current validation of the permit; and


shall also include a motor vehicle which is in a wrecked or dismantled condition or has had its source of power removed.

3. THAT By-Law No. 23-01 is hereby amended.

4. THAT this By-Law shall come into force and take effect upon the final passing hereof.




