<b>Definitions</b>			
<b>Family</b>	Mother/Father/Child or other Immediate Family Member 17 years and younger residing at same residence.		
<b>Single (Adult)</b>	Person 18 years and older.		
<b>Student</b>	Person aged 18 and older attending a University, College, Community College, Trade School or other Educational Institution. Must have a student identification (I D) card.		
<b>Senior</b>	Person 65 years and older.		
<b>Child</b>	Person between the age of 3 and 17 years.		
<b>Toddler/Infant</b>	Person under the age of 3 years.		
<b>Conditions</b>			
* In the event the Ferry is removed from service for a mechanical or other circumstance, as these situations are beyond the immediate control of the Municipality, there shall be no pro-rating or reimbursement of either the monthly or annual fees paid.
