- Complete the Pre-Ceremony Information Questionnaire for review with the Marriage Commissioner (see page 9)
- Review Civil Marriage Ceremony Guidelines (see page 5)
- Determine a location for the Ceremony
- Make arrangements for 2 witnesses, preferably over the age of 16. (see page 6)
- If required, please make arrangements for an interpreter for the Ceremony. (see page 6)
- Choose Vows for your Civil Marriage Ceremony. (included in package - see pages 11, 13, 16) **Additional approved wording for civil marriage ceremony is available, please review with the Marriage Commissioner.**
- Choose or prepare personal vows. **If this option is chosen, please provide to the Clerk prior to the pre-ceremony meeting for approval.**
- Pay for all required fees in accordance with this package (plus those to the Marriage Commissioner).
- Arrange for any music, videographer, photographer and decorations.

### REMINDER:

As part of the process to obtain a Marriage License, it is recommended that you complete an application form for a Marriage Certificate approximately three (3) months following the date of Marriage. The Municipality of Red Lake currently offers civil marriage services. Through the delegation of the Clerk's authority. The Municipality of Red Lake's Civil Marriage Service is a non-denominational and dignified ceremony, which adheres to the requirements of the Marriage Act for the Province of Ontario.

### **Civil Marriage Ceremony:**

Civil Marriage Ceremonies, available in English only, are simple and dignified. The Marriage Commissioner will conduct such services at any location in Ontario subject to certain conditions, but are authorized to perform such services within the boundaries of The Corporation of The Municipality of Red Lake and the surrounding unincorporated area. The Ceremony can last up to a maximum of thirty (30) minutes depending on the vows chosen. The service time booked would be approximately one (1) hour to allow for photo opportunities etc. If an interpreter is required, more time would be needed.

Ceremonies can also be conducted in Council Chambers which provides an intimate and formal setting. While the Council Chambers may be available Monday through Thursday, Fridays are designated specifically for the provision of civil marriage ceremonies.

Same day service for a Civil Marriage Ceremony is possible provided a valid Ontario Marriage License is produced, the availability of a Marriage Commissioner, and a preferred location. It is recommended that ceremonies be booked in advance to allow for a pre-ceremony meeting at least three (3) days prior to the Ceremony.

The Marriage Commissioner is available to conduct marriages seven (7) days per week, based on availability.

**To help make this important day as beautiful, dignified and intimate as possible; this package contains information to assist you with learning more about the Civil Marriage Service, and plan your Ceremony.**

### **Enclosed you will find:**

#### **(a) Civil Marriage Ceremony Guidelines, including applicable fees:**

The guidelines provide answers to frequently asked questions with regard to Civil Marriage Ceremonies at the Municipal Office including fees, restrictions, requirements, etc.

**(b) Civil Marriage - Booking Agreement:**

A booking is not confirmed until this Agreement is completed and returned to the Municipal Clerk's Office with full payment (cheque, cash, visa or debit).

*The ceremony Booking fee does not include the Marriage License fee of \$125.00 which can also be obtained through the Municipal Clerk's Office.*

**(c) Pre-Ceremony Information Questionnaire:**

This information will assist the Marriage Commissioner and the Applicants to plan and coordinate the details of the Ceremony.

**(d) Frequently Asked Questions**

**(e) Sample Vows:**

We have included three (3) examples of vows which the Applicants can choose from. There is a provision to allow Applicants to write custom vows for the Service which can be inserted between the mandatory declarations required under the Marriage Act. **If this option is chosen, please provide to the Clerk prior to the pre-ceremony meeting for approval.**

1. Effective June 1, 2009, the Municipality of Red Lake began offering civil marriage services.
2. Civil Marriage ceremonies last a maximum of thirty (30) minutes, depending on the vows chosen. The service time booked would be approximately one (1) hour to allow for photo opportunities and use of an interpreter if required.
3. Civil Marriages will be conducted in English only at any location within the Municipality of Red Lake and the surrounding unincorporated area, subject to confirmation by the Marriage Commissioner. If the ceremony is to be held anywhere else in Ontario, further approvals are required. The Marriage Commissioner is available to conduct marriages seven (7) days per week, based on availability.
4. Services can also be conducted in the Council Chambers at the Municipal Office, 2 Fifth Street, which provides an intimate and dignified setting. The Council Chambers however, is only available during regular business hours 8:30 a.m. to 4:30 p.m., Monday to Friday ONLY subject to availability. The Municipality of Red Lake has set aside Friday afternoons for this purpose between the hours of 1:00 p.m. and 4:00 p.m. Council Chambers will NOT be available on weekends, Civic or Statutory Holidays or anytime after 4:30 p.m. However, ceremonies at other locations can be held seven (7) days a week.
5. **FEES:** (All fees shall be subject to taxes as applicable.)
  - a. Payments are to be made at the Municipal Office and can be done by cheque, cash, visa or debit. All fees are payable in advance at the time of booking and require the execution of a Booking Agreement. A percentage of these fees are paid to the Marriage Commissioner. A blank Booking Agreement form is included in this package for your reference. The following fees for Civil Marriage Services, as approved by Council and identified in Schedule "J" to the Municipality of Red Lake User Fees and Charges By-Law:

- b. The Marriage Commissioner may charge for travel, accommodation, meals and mileage costs, at their discretion, to attend a ceremony in any approved location, as well as an hourly fee over and above the approximate time allowed for a Civil Ceremony and for participation at a rehearsal, regardless of its location.

Please note: Fees referred to in 5 b. are separate and apart from the Municipality’s fees and as such shall be paid directly to the Marriage Commissioner by the applicant.

- c. Municipal fees as shown in 5. a. are payable to the Municipality of Red Lake at the time of booking. Please note the Civil Marriage Service does not include the fee for the Marriage License or use of the Council Chambers.
- d. The fee for a Marriage License is \$125.00 (no tax, includes administration fee). More information regarding the application process for obtaining a Marriage License in Ontario can be obtained by accessing the Government of Ontario website or from the Clerk’s Office at the Municipal Office.
- e. The fee for the use of Council Chambers is \$75.00 per ceremony, and is only available for ceremonies conducted in the Council Chambers at the Municipal Office (the Council Chambers is not available after 4:30 p.m. or on weekends/holidays).
- f. Changes to date and/or time are permitted at no additional charge, provided the location and the Marriage Commissioner is available and must be received a minimum of two (2) business days prior to the originally scheduled date and time. An administration fee of \$50.00 will be applied should the Ceremony be cancelled prior to the scheduled date. No refund will be issued if the Ceremony is cancelled on the day of the Ceremony, or the Applicant(s) fail to appear for the Ceremony. A Request for Refund – Civil Marriage Service form (available from the Office of the Clerk) shall be completed prior to any reimbursement of funds.



## Civil Marriage Service Guidelines – Continued

6. It is recommended that a request for a Civil Marriage Ceremony be received a minimum of three (3) days prior to the date of the Ceremony. The applicants are required to complete the Civil Marriage Booking Agreement and pay the appropriate fee at the Municipal Office. As well, applicants must complete a Pre-Ceremony Information Questionnaire with the Marriage Commissioner.
7. The Marriage Ceremony lasts a maximum of thirty (30) minutes. Plan to arrive at least fifteen (15) minutes prior to the Ceremony to allow time for review of final details.
8. A Pre-Ceremony meeting with the Marriage Commissioner is required and lasts approximately fifteen (15) minutes and is to be scheduled at least three (3) days prior to the ceremony (exception as noted in No. 6 above). Please ensure you have the following available for the Marriage Commissioner at this meeting:
  - ✓ Both parties must be in attendance and provide photo identification;
  - ✓ Bring copy of the Completed Pre-Ceremony Information Questionnaire;
  - ✓ Bring completed copy of Civil Marriage Service Booking Agreement (with receipt);
  - ✓ If specific vows are to be included, please provide a written approved copy to the Marriage Commissioner;
  - ✓ If an interpreter is to be used, provide an applicable form to the Marriage Commissioner with details;
  - ✓ Provide a valid Marriage License (with receipt) issued in the Province of Ontario is to be presented  
(date issued must be within three (3) months of ceremony).

*It is preferred only the couple meets with the Marriage Commissioner during this session.*

### **Please Note:**

**It is the Applicants' responsibility to provide an interpreter if they do not speak English and/or require language assistance. The interpreter cannot be one of the witnesses. The interpreter shall be required to sign a form confirming that he/she has interpreted the wedding ceremony.**

**There is no minimum age requirement for a witness, however, it is suggested they should be at least sixteen (16) years of age, as a witness should be able to understand and appreciate what is taking place and be able to give evidence of such at a later date, if required. It is the Applicant's responsibility to provide the witnesses.**

**The Record of Solemnization of Marriage provided at the ceremony is not a legal record. Approximately three (3) months after the ceremony you may apply to the Office of the Registrar General to obtain an official Certificate of Marriage. The appropriate form is included with the Marriage License that was issued to the applicants.**

## Civil Marriage Service Guidelines – Continued

9. Alcohol or stimulants are not to be used by the Applicants or their witnesses prior to or during the Ceremony. If the Marriage Commissioner has reason to believe that alcohol or other stimulants have been used, the Ceremony will not proceed.
10. In order to maintain the dignity of the Ceremony clothing should be appropriate for the occasion.
11. Music will be permitted at certain times throughout the Ceremony, and is to be determined during the pre-ceremony meeting. When selecting the type of music, consideration should be given to its appropriateness and contribution to the dignity of the occasion.
12. A maximum of twenty (20) guests (not including the wedding party) can be accommodated in the Council Chambers should this location be used for a civil marriage ceremony.
13. The taking of photographs will not be permitted during the Ceremony. An opportunity will be provided for photos before the ceremony begins, during the signing of the Register, and when the Ceremony is complete. Videotaping of the Ceremony may be permitted subject to certain limitations at the discretion of the Commissioner.
14. No confetti, rice, bubbles etc. are allowed in the Council Chambers or on municipal property. Smoking and/or use of candles are not allowed in or on the Municipal Office property.
15. For use of the Council Chambers at the Municipal Office, minimal decorations are permitted (e.g. flowers, balloons). They may be placed 15 minutes prior to the Ceremony and removed within 15 minutes of the conclusion of the Ceremony. Use of decorations that are to be affixed to walls or furniture (i.e. tape, staples, nails, etc.) are not permitted. The Municipality of Red Lake will provide silk flower arrangements should it be requested.
16. The Applicants, as the renters of the Council Chambers for the Civil Marriage Ceremony, hereby consent to defend and indemnify The Corporation of the Municipality of Red Lake for any loss or damages incurred by their invitees. The applicants agree that The Corporation of the Municipality of Red Lake will not be held responsible for personal injury or damage, nor for the theft or loss of any personal property of anyone attending on the invitation of the Applicants.
17. The renter shall be responsible for the conduct and supervision of all persons admitted to Council Chambers and shall see that all regulations pertaining to the event are strictly followed.
18. The Council Chambers may only be used for civil marriage ceremonies conducted by a Municipality of Red Lake Marriage Commissioner, or the Clerk or designate, if necessary. The Chambers will only be made available for a maximum of one and one-half hours per ceremony; minimal decorating permitted.

## Frequently Asked Questions

### 1. What documents are needed for a Civil Marriage Service?

Before meeting with the Marriage Commissioner you should have completed and paid for your Ontario Marriage License (valid for three (3) months following its date of issue), which you should show the Commissioner. You should have also completed the Booking Agreement Form with staff at the Municipal Office. The Pre-Ceremony Information Questionnaire you will complete during the pre-ceremony meeting with the Marriage Commissioner. Both forms are included in this package.

### 2. Who may officiate at our wedding?

For a Civil Marriage, the Municipality's appointed Marriage Commissioner(s) may perform the ceremony.

### 3. What would it cost to be married at my home on the lake on Saturday?

(All fees are subject to applicable taxes.)

Example 1: Location within Municipal boundaries:

• Marriage License issued in Red Lake .....	\$ 125.00
• Ceremony on a Saturday (within the boundaries of the Municipality) .....	<u>\$ 350.00</u>
TOTAL	\$ 475.00*

Example 2: Location in unincorporated territory: (All fees are subject to applicable taxes.)

• Marriage License issued in Red Lake .....	\$ 125.00

### 4. Does the Municipality offer “same day service” for a Ceremony?

Same day service for a Civil Marriage Ceremony is possible provided a valid Ontario Marriage License is produced, the availability of a Marriage Commissioner, and a preferred location. It is recommended that ceremonies be booked in advance to allow for a pre-ceremony meeting at least three (3) days prior to the Ceremony.

### 5. Where can we hold our wedding?

Our Marriage Commissioner will perform a ceremony anywhere within the jurisdiction of the Municipality of Red Lake, and its surrounding unincorporated area. Ceremonies may also be held at the Municipal Office in the Council Chambers, based on availability.

**6. Do we have to purchase our Ontario License in Red Lake to be married in Red Lake?**

No. You may purchase an Ontario License anywhere in the Province of Ontario to be married anywhere in the Province of Ontario.

**7. Are witnesses required for a Civil Marriage Ceremony?**

Yes, all couples must have two (2) witnesses present during the ceremony, preferably over age 16.

**8. May we include readings from the Bible or have a Blessing at our ceremony?**

No, in keeping with the spirit of the Ontario Marriage Act which requires civil ceremonies to be “non-denominational” the Marriage Commissioner or any other person may not perform any type of religious ceremony.

**9. Will Marriage Commissioners marry Same-sex Partners?**

Yes, there is a constitutional requirement in Ontario to issue marriage licenses to, and solemnize civil marriages of same-sex couples.

**10. Who registers our Civil Marriage?**

After the ceremony all parties must sign the Record of Solemnization (to be retained by the couple) and the Statement of Marriage, both are included on the license. The Marriage Commissioner will ensure all documentation is delivered to the Municipal Office following the ceremony so it can be forwarded to the Office of the Registrar General in Thunder Bay within two (2) business days to register your marriage with the Province of Ontario.



**CIVIL MARRIAGE CEREMONY**  
**OPTION #1 – NO RINGS**

**OPENING**

We are gathered at this place for the purpose of joining in the legal state of matrimony (this man and this woman / these two people), under the authority given and provided by the Government of the Province of Ontario.

Marriage is not to be entered upon thoughtlessly or irresponsibly but with a due and serious understanding and appreciation of the ends for which it is contracted. Therefore if there is any one present who can show just cause why these two persons may not be lawfully joined together in matrimony they should now declare it or hereafter remain silent.

*Marriage Commissioner to 1<sup>st</sup> Person: Repeat after me please:*

I do solemnly declare that I do not know of any lawful impediment why I, \_\_\_\_\_  
\_\_\_\_\_ may not be joined in matrimony to \_\_\_\_\_.

*Marriage Commissioner to 2<sup>nd</sup> Person: Repeat after me please:*

**If either person is escorted forward, Marriage Commissioner states:**

“Who is it that gives this \_\_\_\_\_ (man/woman/these individuals) in marriage?  
Answer “I/we do”. (father, mother, children, relatives, etc.)

**DECLARATION OF INTENT AND VOWS**

*Marriage Commissioner - Would you please face each other, join hands and repeat after me.*

*Marriage Commissioner to 1<sup>st</sup> Person:*

I call upon these persons here present, to witness that I, \_\_\_\_\_ do take  
you, \_\_\_\_\_  
\_\_\_\_\_ to be my lawful wedded (wife/ husband/ partner/ spouse). To  
have and to hold from this day forward. For better, for worse, for richer, for poorer, in sickness

Marriage Commissioner to 2<sup>nd</sup> Person: Repeat after me please

## Alternative Ceremonies

### 1. Love/Wine Box

At this time I'd like to draw your attention to the box beside \_\_\_\_\_ and \_\_\_\_\_. They have written letters to each other expressing their feelings as they begin their marriage. They have detailed why they fell in love and what they truly admire about the other person.

These letters were sealed before they could be read. We will include these letters in the box along with a bottle of wine and two wine glasses. Together we will seal the box, and on the happy occasion of their anniversary, they will open the box, and read the letters.

By reading these love letters, you will be given an opportunity to reflect upon the reasons that you fell in love with each other.

(love letter carriers) \_\_\_\_\_ & \_\_\_\_\_ will you please bring up the letters?

\_\_\_\_\_ and \_\_\_\_\_, I now ask you to place the letters in the box and seal it shut.

### 2. Sand Ceremony #1

We now celebrate \_\_\_\_\_ and \_\_\_\_\_'s union with a symbolic sand ceremony. First, we will pour sand from this beautiful beach where \_\_\_\_\_ and \_\_\_\_\_ stand today as they commit their lives to each other, representing the strong foundation of their relationship. That foundation includes their families, their upbringing, and all the important steps on their journeys that led them to be who they are today. This foundation will support them in their love as they grow and change together. *(If you are not having a beach wedding, the foundation sand can be from your hometown, or just a neutral white sand.)*

\_\_\_\_\_ and \_\_\_\_\_, today you are making a lasting commitment to share the rest of your lives with each other. That commitment is symbolized through the pouring of these two individual containers of sand; one that represents \_\_\_\_\_ *(who now pours in some of his/her sand)* and the other that represents \_\_\_\_\_, *(who pours some of his/her sand on top)*.

Each of you comes to this relationship with unique strengths, vulnerabilities, and histories. As individuals, you are beautiful people all on your own. Yet when the two of you are blended together, you form something even more beautiful. Those strengths can blossom, those vulnerabilities can be cared for, and those people can soar.

As the two containers of sand are poured into the vase, (both \_\_\_\_\_ & \_\_\_\_\_ simultaneously pour their remaining sand in the central vase) the separate colours of sand now blend into a new colour.

You have now blended your families into a new family, as you start your journey in marriage, loving and strong as husband and wife, as inseparable as these grains of sand.

## **Sand Ceremony Wording #2**

Love is a force more formidable than any other. It cannot be seen or measured, yet it is powerful enough to transform you in a moment, and offer you more joy than any material possession ever could. But although this love joins you together as one, remember the gift of your individuality. Cherish and affirm your differences as you love each other. Be supportive of your strengths, and tender towards your weaknesses. Laugh together, cry together, be comforted by each other's presence, and secure in each other's absence.

To symbolize the importance of each of you within the marriage and the joining of your two lives into one marriage, 3 colours of sand will now be combined in a sand ceremony.

We begin with a layer of white sand, which symbolizes the foundation of the relationship. (Officiant pours some of the white sand into vase)

Then \_\_\_\_\_ and \_\_\_\_\_ will each separately pour their sand into the vase, symbolizing who they are as individuals. (Groom pours some of his sand into the vase and then the bride does the same)

Then, they will pour together, blending their two colors as a symbol of their joining together forever in love. (Bride and groom pour remaining sand at the same time)

Lastly, I will add another layer of white sand, representing you, their community, supporting them in their marriage and holding them in love. (Officiant pours remaining white sand)

## **Sand Ceremony that Includes Children**

First, you will each separately pour a layer of sand into the vase, representing who you are as an individual. *(First one person pours, then the other, forming two distinct layers of sand)*

Then, you will pour simultaneously, blending your two colors as you will blend your lives in marriage. *(The couple pours simultaneously)*

As the individual grains of sand can no longer be separated, may your bond also be inseparable.

As they also contribute their unique personalities and strengths to this new family, they will also individually add a layer of sand to this unity vase. *(Pause as the children pour their sand individually, forming separate layers over their parents' blended sand)*
